Why is the census so critical for students and educators in public schools?

The importance of the U.S. Census to the well-being of children and the strength of public schools cannot be Using census data, the federal government allocates tens of billions of dollars in education funds to states and localities annually using formulas that factor in population and poverty levels. These programs provide supports for children with special needs and from low-income families. They help reduce class sizes, hire specialists, fund professional development, offer preschool to low-income families, and ensure that hungry students can get breakfast or lunch to help them pay attention in class. Census data are also critical to the Supplemental Nutrition Assistance Program (SNAP), which keeps millions of families out of poverty. You can increase participation by getting your students involved. CVUSD School Board Update

There were some fireworks at the December 17th CVUSD school board meeting with coverage in the local papers and letters to the The board was reorganized that evening with Cindy Goldberg elected as President, Jenny Fitzgerald, Vice President, and Bill Gorback as Board Clerk. During a discussion on adopting Just Mercy (adapted for Young Adults) to be included on the approved literature list, Lou Lichtl, Asst. Supt. Of Instruction did an excellent job supporting our teachers, their ability to handle sensitive topics, and the need of students to read literature that exposes them to a world that may be different from their regular experiences. Sandee Everett expressed a concern that the book might re-traumatize students who may have experienced past trauma. She asked Jordan Scott, our student trustee, if she knew students who had been raped and if they would be affected. This question was inappropriate for an adult to be asking a student especially when these meetings are televised. Ms. Scott did a fine job answering the question, but that question should not have been asked. As the meeting progressed, there were several instances where Ms. Everett was called out of order,

asked to allow other members to have time for discussion, and was called out for name calling under her breath, but caught on the microphone. Finally, Dr. McLaughlin called her out for creating a hostile workplace. He read a list of false accusations she made against him and the CVUSD staff. COURTNEY STOCKTON As you may recall, the entire contract is open this year. UACT asked for bargaining to start over the summer in the hopes that we could get everything, especially the benefits package, taken care of before the school year started. For reasons beyond our control, that did not happen. We started bargaining again in the fall, going through numerous language changes and other conceptual changes like a hybrid model for PD instead of three district lead days. Discussions have been respectful with a good back and forth between the two sides but nothing about a raise has been discussed yet. One thing we do want to make you aware of is a possible issue with regards to the Health Insurance Out of Pocket Maximums (OOP). When we got our last raise, part of the agreement was that we would explore a way to save the district \$250,000 in the Health Benefits plan by February 1st. If we did not find that savings, the district would be allowed to implement an increase to the OOP. All three employee associations believe that since the Health Benefits fund has over \$7 million dollars, there is no need to look for the agreed upon savings. At the last Health Benefits Committee meeting on December 10th, the employee groups presented a united proposal asking the district to waive the language regarding the savings and to freeze the employee only contributions. So far, while they have not specifically said no, they have not yet agreed to waive the language or freeze employee only contributions. Stay tuned for further updates regarding this issue. Our next bargaining session is on January 13th.

THE BOARD HAS APPOINTED A COMMITTEE TO LOOK AT OUR BUDGET AND IDENTIFY AREAS TO REDUCE COSTS. SOME THINGS WILL BE ELIMINATED, OTHERS CHANGED, AND SOME WILL BE UNTOUCHED. ADMINISTRATORS AND OPERATIONS MANAGERS HAVE BEEN ASKED TO IDENTIFY AREAS FOR CONSIDERATION. UACT WILL BE SENDING A SURVEY TO OUR MEMBERS AS WELL TO GIVE INPUT INTO AREAS THAT MIGHT BE ELIMINATED, CHANGED, OR NEED TO BE LEFT ALONE. THIS WILL BE SENT TO HOME EMAIL.
